I am happy to publish annual report once again in the year 2022-23 like previous years. It was a challenge for setting up a tribal girls school in Malkangiri that to in a very remote village called S. Tandapalli in the year 1998. We started with 5 students initially with a very small and thatched house but we could able to built trust on the tribal community and gradually the strength of the school increased and now we have 169 children are studying from Class-1 to Class-6. We have concentrated our entire effort and putting energy to built the carrier of the children therefore 80% of our focus is on school only. Last 24 years, we are there with 14 dedicated staffs and thanks to Ministry of Tribal affairs, Government of India for providing Grant-in-Aid on year to year basis. We are very grateful to District Administration of Malkangiri, Government of Odisha, MAP, France and Hand in Hand, Germany for their matching support to make the good quality Student Dormitory, Class rooms, school furniture and Campus boundary of the school.

I am also very grateful to Governing Body Members, Advisors and villagers of Tandapalli for their continuous support.

I remain with thanks to all and requesting to continue to extent their love, affection to success the mission.

About the Organisation:

The name “SEED” stands for Social Education for Environment and Development organisation which came into existence in the year 1991 when a group of development practitioners and social activists witnessing the plights of commons in Malkangiri joined to a platform for taking uniform approach towards development. SEED is a secular & non-political organization that stands for the poor & marginalised scheduled caste, scheduled tribe and other backward class people of the society. SEED is managed by experienced

development professionals having years of work exposure in tribal locations. Besides retaining experienced professionals the organisation has engaged young & energetic community workers who possess first-hand knowledge as well as countless ideas of problems and opportunity in the tribal set up. The organization focuses on themes of education, livelihood, environment protection, women empowerment, health and capacity building of the tribal in general and vulnerable groups in particular.

The organisation is registered under the following legal provisions.

- Registered under Indian Societies Registration Act XXI of 1960.
- Foreign Contribution Regulation Act (FCRA) in 2005 bearing FC registration no 105090006.
- Income Tax act 12A and 80G

Our Vision

- To empower the Malkangiri people to build a healthy, ecologically sustainable, socially active society.
- To prepare the Malkangiri people to lead a quality life with access to, and control over their own resources.

Our Mission:

- To work for the empowerment of tribal women and children.
- To provide primary education to tribal girls.
- To organise rural poor for their own development
- Reduce poverty and dependency syndrome
- Work for the basic health care of community
- Lowering of death rates and enhancing quality of life
- Rehabilitation of disable people.

Approaches:

SEED believes that communities possess an inherent power that enables them to improve the capacities of the people in the area. Communities can do this by creating an environment in which the community can gain access to as well as control over the common resources. SEED treats each and every tribal set as a microcosmic unit, distinguished by distinct lifestyles and cultures. The different features of each tribal set makes it necessary to develop a context specific approach for development. SEED employs a holistic approach when addressing tribal problems. Instead of providing a quick fix solution to the problem SEED tries to find out a long term sustainable solution to the problems. This cannot be done without participation by the people of the community and so SEED tries to build up organizations to stand on their own without any dependency on external groups. SEED is an external catalyst to the development of these communities.

Operational area:

SEED operates in Malkanagiri district of Odisha. This district was earlier a part of Koraput district and because of reorganization was segregated as a separate district in the year 1992. Most of the part of the district is covered with dense inaccessible forests, small but beautiful rivers, undulating plateaus and splendid rich tribal culture. Because of inaccessibility and bordering two extremism prone states i:e Chhattisgarh & Andhra Pradesh the people often encounter naxal's murder . Located in a large distance from the state capital as well as predominated with primitive tribal communities of Bonda, Koya, Paraja and Bengali refugees' development has been over crippled here. With high prevalence of poverty, malnutrition, migration and land alienation has forced tribes to lead a life with lesser means. The encroachment and penetration of people who are not a part and parcel of the tribal ecosystem are virtually straining the social fabric. The tribal culture has either lost or given to other alienated cultures in silence. Though the region is resource rich, yet most of the raw materials are used in the primary sector minimizing the return. Due to large scale deforestation and exfoliation, the landscapes are eroded .The natural resources are abundant. The jungles and vast stretches of agricultural land are still used in the most primitive ways. In this operational area SEED tries to intervene into the following key issues, bringing solutions to the social issues. Presence of middlemen in every cycle of production be in agriculture or industrial, has even more marginalized the profit. Thus due to low profit and less agricultural productivity has forced the people to migrate.

With this scenario SEED started working in Malkangiri district in the year 1991. The organization conceptualized that Empowerment can only take place when women, weaker sex are enlightened through education as education only can emancipate them from despondency. Accordingly SEED put its step through the residential education programme of tribal girls. The current education system which is non- tribal in context, culture as well as symbols keeps tribal girls shy away from education. It was a big hurdle to bring the girls as parent's perception of education was unworthy for them. Parents rather prefer their daughters to be engaged as baby sitters at home while they go away for wage earning. With continued counseling to parents, SEED mobilized the girls to the centre and continues to deliver context specific and culture suitable primary education to the girl children. SEED believes that only education to women can bring solutions to many a number of problems. The education must be provided at No Cost to the tribal girls along with nutritious food and stationeries.



Educational Complex for Tribal girls:

SEED is being supported by the Government of India in implementing an educational complex for tribal girls. The complex, named SEED Kanyashram, has a special focus on female literacy. It incorporates a targeted scheme to strengthen education among scheduled tribe girls, and specific components that improve girls' education. SEED Kanyashram has been established and managed by



SEED at Tandapalli village of Korukonda block, Malkangiri district, Odisha since February 1998. Currently, 169 tribal girls are being provided with primary education up to class 6.

Class wise student's strength is depicted below. (Academic session 2022-23)

During this reporting period, we have conducted a campaign in the month of April 2022 for admission of students, and 26 new students were enrolled in the school. From 6th June to 16th June and from 1st October to 11th October 2022 the school was closed due to summer vacation and puja vacation respectively. Prior to summer vacation, students were assigned with different lesson work to complete at home. During the summer vacation, we also organized a two day orientation program for teachers, where we prepared syllabus, lesson plans and annual plan for the new academic year 2022-23.

Students have received uniforms dresses , teaching learning materials like books, note sheet, teaching materials and monthly sundry items like soap, washing powder, bath soap, and oil. Health checks up and medicine also provided to them. In the case of major illness in students, they have been referred to the district head quarter hospital for treatment. During the leisure hour vocational training like horticultural work



imparted to them. In the school premises students have done handicraft work like making toys, mats, involve kitchen garden and vegetable cultivation, plantation of papaya plants, lemon, mango etc. They have also done flower garden and fish cultivation in the pond with help of staffs The quality of school life is determined by its activities". Our school truly believes that physical as well as mental activities play a vital role in building a bright future of the children. There are lots of co-curricular activities that are held in our school. Students of SEED Kanyashram have participated in physical exercise indoors and out door games, drawing, painting, song and speech completion etc. The school provided special food during festivals and observation of important days.

Observed festivals like Utkal Dibas, R̄ma Navam, Pana Sankranti, Akshaya Tritiya, Debasnana Purnima, Raja Parba and Car festivals , New year, Republic day ,Makar Sankranti, Nataji Jayanti, Ganesh Puja , Saraswati Puja, Dola purnima, Holi, Children's Day, Teacher's Day, Independence Day and Ram Nabami in the school campus with fun and happiness etc .

Half yearly and annual examinations were conducted at SEED Kanyashram and necessary teaching and learning materials were provided to all the children.

SEED Kanyashram organized a parents meeting in the month of November 2022 and shared with them about the status of each students In the meeting both parents and children were participated. Conducted annual sports, cultural meet and picnic programme to Satiguda during the reporting period.



Parents Teachers Meeting

The parents teachers meeting is being held to improve the educational atmosphere and the quality of teaching. The committee has also discussed the status of school, performance of girls students. They also suggested for continuation of student's education and participation of parents for in the school in different occasions.



Annual Inspection

As per Government instruction a team(DWO, DI of Schools and Welfare Extension Officer, Malkanagiri) headed by District Welfare Officer, Malkanagiri visited the school on 25th Feb 2023 and interacted with staff and suggested necessary work for the school. The inspection team visited the existing hostel, lavatory, dining, classroom and kitchen to assess the performance of students and present status of this infrastructure of the school. Verified school documents and records for annual inspection report. Overall satisfied with the existing situation and performance of the school.

Women Empowerment Programme:

Women empowerment and livelihood programme is one of the focus activities of SEED. In this year SEED organised a meeting and training among women Self Help Group shared with them for social inclusion, economic inclusion and financial management in their respective group members. In addition to this they have also encouraged for regular savings, and different income generation activities. The income generation programmes through these SHGs have not only transformed women into Income Generator but also instilled a sense of



confidence among them. SEED has imparted training on reproductive health care, institutional delivery, use of safe drinking water, use mosquito nets, use of sanitary toilets, promotion of kitchen gardening through different schemes of government .

Campus development work

SEED raised income from the pisciculture in the pond located behind the old hostel building in the campus. A total of 10 quintals of fish were caught from the pond this year and all fishes are eaten by the school children. Likewise seasonal vegetables Lemon also sales from the campus

During the rainy and winter seasons, the



complex has planted green leafy vegetables, brinjal, cabbage, cauliflower, chilli, tomato, and pumpkin in the small kitchen garden of campus. A lemon garden was also planted inside the campus. Seasonal flowers of Marigold, Jasmine, and Hibiscus etc are also grown to create a greenery look.

Solar panel installation at top of the hostel building for renewable energy during emergence and to manage at the time of electricity power cut. Others work like

Coloring, electrical fittings, repairing water pump , toilets , iron beds and building part of the hostel, constructing, and ensuring beautification and regular cleanliness of the school campus .

Capacity building training

Periodically SEED management has organized capacity building for its teaching staffs about preventive mechanisms and awareness created in the community, imparted education to children for continuation of their study, preparation of teaching aids, day to day documentation of schools etc. A five -day training was conducted for staff members from 27/04/2022 to 28/04/2022 on teaching health and hygiene, sanitation, teaching methodology, documentation, care and protection of children, child care and education, psycho-social development of children, and the maintenance of records and documents for children in child care institutions.

Sponsored Ship Programme

Under the sponsored ship programme the SEED Kanyashram (Tandapally) rendered additional support to 26 tribal girls students like dress materials , foodstuff, healthcare and teaching materials etc. Furthermore a new class also stated for class sixth students now 36 students enrolled in class sixth .We have rendered health care , Supply learning materials, dress materials vegetable cultivation, flower planting in the garden, renovation work and purchase play equipment, renovation building part of the hostel, and ensuring beautification and regular cleanliness of the school campus etc. During special days and national programme additional food stuffs, provided to children.

Environment Awareness Campaign:

On 5th June 2022 SEED organizes Environment awareness programme and demonstration set ups for issues like deforestation and recycling of waste material for reuse etc. One day awareness meeting was organized by SEED at its school premises and total 40 participants like women self help groups, PRIs , integrated child development teachers, ASHA workers, Youth members, teachers, were participated in the programme.

Infrastructural Development in SEED School campus

SEEDI has been active in female education in the village of S.Tandapalli of Malkanagir district since 1998 and has started a tribal girl's school with 50 girls. Now more than 169 tribal girls' children are continuing primary education from class 1 to class 6 in the school. The existing class room and hostel are not sufficient space for accommodation and classes. One additional class started from 2022-23 academic session (class -(vi) with 36 students . The old hostel building is 20 yrs old tin roof and mud wall. So based on the present need of the school SEED



constructing a new School building and renovating of the existing old hostel building for accommodation and class room of children. All the construction work is going on and which will be completed before July 2024.

Observation of international women's day: 2023

On 8 March the women staffs at SEED celebrate International Women's Day in its school campus base on the theme 2023 for international women's day is Embrace Equity. The program included meeting among women, organised small events among girls students.All female teaching and non teaching staffs were participated in the programme . Local PRIs member shared their At the end all participants were appreciated the efforts been taken all the women for empowerment at SEED through various life skill education and capacity building training.

Programme on violence against women and girl

On 2nd Dec 2022 SEED staffs organized awareness programme on violence against women and girl. Which focused on to create awareness to all the participated women and girls about gender based violence, female literacy, legal provisions and various skill training opportunities available for them to become economical independent and self reliance. Total 38 members' participants like female staffs, and local SHG women were participated.

Dear Sir / Madam,

With reference to your on-line application no. 20857/2022 and subsequent correspondence with the school / inspection in this regard, I convey the grant for issuance of **Certificate of Recognition** to **SEED KANYA ASHRAM PS, S. TANDAPALLY** for Class- I to Class- V for a period of five years w.e.f. **dtd.01.04.2022 to dtd.31.03.2027.**

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize / affiliate beyond Class-V.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Odisha Right of Children to Free and Compulsory Education Rules 2010.
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society / School shall not collect any capitation fee and subject the child of his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission.

On the ground of religion, caste or race, place of birth or any of them.

7. The School shall ensure:
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 22.
 - (v) Inclusion of Students with disabilities / special needs as per provision of the Act.
 - (vi) The teachers are recruited with minimum qualifications as laid under Section 23(1) of the Act.
 - (vii) The teacher performs its duties specified under Section 24(1) of the Act and the teachers shall not engage themselves for private teaching activities.

8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The School shall enroll students proportionate to the facilities available in the school asprescribed in the Section 19 of the Act.
10. The School shall maintain the standards and norms of the school as specified in Section 19 of the Act. The facilities reported as the time of last inspection are as given under:-
 - Area of school campus
 - Total built-up area
 - Area of play ground
 - No. of Class rooms
 - Room for Headmaster-cum-office-cum-storeroom
 - Separate toilet for boys and girls
 - Drinking Water facility
 - Kitchen for cooking Mid Day Meal
 - Barrier free access
 - Availability of Teaching Learning Material / Play Sport Equipments / Library.
11. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
12. The School buildings or other structures or the grounds are used only for the purposes education and skill development.
13. The School is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force;
14. The School is not run for profit to any individual, group or association of individuals or any other persons;
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.
16. The recognition Code Number allotted to your schools is 0162022. This may please be noted and quoted for any correspondence with this office.
17. The School furnishes such reports and information as may be required by the Director, Elementary Education / District Education Officer / Block Education Officer as the case may be from time to time and complies with such instructions of the State Government / Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the schools;

Such exemption from taxation will be available only after the Assessing Officer is satisfied about the genuineness of the activities promised or claimed to be carried on in each Financial Year relevant to the Assessment Year and all the provisions of law acted upon. This will be further subject to provisions of section 2(15) of the Income Tax Act, 1961.

A public notice of the activities carried on/ to be carried on and the target group(s) (intended beneficiaries) shall be duly displayed at the Registered/ Designated Office of the Organisation.

i. The Trust/ Institution shall furnish a return of income every year within the time limit prescribed under the Income Tax Act, 1961.

j. Separate accounts in respect of profits and gains of business incidental to attainment of objects shall be maintained in compliance to section 11(4A) of Income Tax Act, 1961.

k. The registered office or the principal place of activity of the applicant should not be transferred outside the jurisdiction of Jurisdictional Commissioner of Income Tax except with the prior approval.

l. No asset shall be transferred without the knowledge of Jurisdictional Commissioner of Income Tax to anyone, including to any Trust/ Society/ Non Profit Company etc.

m. The registration so granted is liable to be cancelled at any point of time if the registering authority is satisfied that activities of the Trust/ Institution/ Non Profit Company are not genuine or are not being carried out in accordance with the objects of the Trust/ Institution/ Non Profit Company.

n. If it is found later on that the registration has been obtained fraudulently by misrepresentation or suppression of any fact, the registration so granted is liable to be cancelled as per the provision u/s section 12AB(4) of the Act.
